# Medi-Cal for Long Term Care Professionals

## ABOUT CANHR

CANHR is a private, non-profit organization dedicated to improving the quality of care and the quality of life for California's long term care facility residents. CANHR educates, residents, relatives, social workers, discharge planners and attorneys about resident's rights and remedies under the law, estate planning, Medi-Cal and placement options.

## COURSE DESCRIPTION

If you are working in nursing home admissions, hospital discharge planning or with elders in the community, it is imperative that you have current, accurate information about Medi-Cal eligibility and Recovery. Medi-Cal coverage is the payer for nearly two-thirds of the nursing facility population. In addition, as the population ages, issues regarding treatment decisions are becoming prevalent.

- Learn about CANHR services
- Understand the eligibility requirements for Long Term Care Medi-Cal and the expected changes coming with the implementation of the DRA.
- Ensure that your clients are accurately informed about Medi-Cal Recovery issues
